

# Disclosure of transparency notification

## (article 14, first paragraph, of the Law of 2 May 2007)

### I. Notification by Vastned NV of 26 May 2026

#### Summary of the notification

As a result of the disposal of treasury shares on 21 May 2026, Vastned NV now holds less than 15% of the shares of Vastned NV as a result of which the 15% threshold was crossed downwards. The voting and dividend rights attached to the remaining treasury shares shall continue to be suspended.
